# FOUNDATION MUTANYANA WERU

SHORT ANNUAL REPORT 2009

In September 2008 the Centre has been taken over by the Congregation of the Orionites. As a result of this, the former side project (named reintegration) became the main project. The year of 2009 was fully dedicated to the purchase of pieces of land, the construction of small houses and huts on these lands and cultivating them.

Father André, now 72 years young, can spend all of his time to supporting this new main project. The car stayed in his own possession as did the driver (on a part time basis). Thus he can freely visit the participants of the project on the various locations.

## **Re-integration Project**

50 former residents of the Centre qualified for this new re-integration project.

With the permission of some donor organisations funds have been re-allocated to this new main project. Originally these funds were allocated to the so-called "chicken project". Additional funds came from other external donors.

With this money new pieces of land have been purchased and small houses were built. All houses also have small pieces of land for

cultivation of vegetables and fruits.

A new foundation is in the process of establishing and so-far provides seeds and seedlings. The aim is the people to become self supporting and to trade on the local market with future surplus yields.

An English couple provides training and supports the people of the project.

The location of all the houses and fields are all within a circle of 30 km. around Maputo and are as shown below:

- 9 houses in the district of Marracuene with 30 people (17 of these are younger than 18 years)
- 2 houses in Bobolo for 5 persons
- 4 houses in Maputo for 15 persons (7 of which are younger than 18 years)

Father André continues to be involved with his work in the Central Hospital in Maputo. Whenever he needs permanent help for e.g. sick people, he hires ex-employees of the Centre.

Apart from the main project: re-integration, there are the side-projects demanding a lot of Father André's time and energy: schooling support, HIV and emergency help.

In order to secure the house and surrounding grounds legally, a new Association is in the process of establishing. The articles of association are now at the Ministry of Justice for approval. The new association will be named: "Filhus de Mutanyana Weru". The Association will also function as a housing association/cooperation lead by the participants of the project. They will be supported by external advisors; Father André will be one of them.

## Visit of "De Wilde Ganzen"

In the past the Dutch organisation "De Wilde Ganzen" sponsored the Centre various times. Two of their co-operators, Daniëlla de Winter and Sabien Deneer, visited various projects in and around Maputo. They also visited Father André at that time. For their internal magazine, "Berichten van Wilde Ganzen", they wrote an article on this visit. They also wrote a report for our Foundation and this can be read on our web-site under the head: "Visits to Maputo".

## **Finances:**

In 2009 our Foundation again managed to collect  $\notin$ 28 000 and this amount of money has fully been transferred to the bank account in Maputo-Mozambique.
