

Mutanyana Foundation Newsletter Weru June 2022

In December we sent you the news of the death of our Father André van Zon and we informed you that in principle we want to continue the work of Father André.

It is crucial to find a local confidential counselor or people who want to do the work on the spot.

In Maputo, Father André lived in the rectory of the parish of Saint Anne of the Diocese. Over the past few years, the occupation of priests has been composed of the Dutch Fathers Father André and his fellow brother Father Huub Kuijpers and four Mozambican priests.

We have had contact with Father Kuijpers a number of times by email and Skype. When he cleaned up Father André's room, Father

Kuijpers said that he found a list with the names of his protégés so that we at least know who they are.

Father Kuijpers has also indicated that he wants to fulfill a coordinating role temporarily (given his age in his eighties). He has found a group of volunteers, consisting of 3 women and 1 man, willing to carry out the work. This group consists of lay volunteers associated with the congregation, the so-called Agregados.

Payment to protégés will no longer be in cash but through a local banking payment system "M -pesa" where money is transferred to a mobile phone - something like Tikkie with us (there was almost no telephone traffic in Mozambique until the arrival of mobile phones when this became common).

All those payments are registered and can therefore be checked.

So as a Foundation we can - for the time being at least - continue to support us in the spirit of Father André. But both Father Kuijpers and us from the Dutch board of our Foundation agree that this support must be temporary so that the protégés have time to integrate socially according to their own independence.

As you can see in the attached financial overview, on 31 Dec. 2021 an amount of approximately € 53 500 in cash.

We have now come up with the following plan to work responsibly towards the end of our support:

- In 2022, 2000 euros /month. to be divided among the protégés (for the remaining months) = € 12,000
- In 2023, the aforementioned group would receive a maximum of € 2000/month. can be pledged = € 24,000
- In 2024 a maximum of € 1500/month. until the zero point is reached.

= € 18,000

Payments for the first installments in 2022 have now been made and have also been distributed among Father André's protégés.

If you calculate the above payments, you can conclude that the money will run out by mid-2024 and we will have to stop the payments. It is also necessary for our Foundation to have

some money in reserve for possible (after) payments of costs to, for example, bank and website.

The decision to end support through the Foundation in this way was discussed with Father André at an earlier stage in 2018. This fulfills his express wish and life mission to support the path to independence for many needy people in Mozambique.

In our decision-making process to establish the 'Mutanyana Weru "in the long term, consultation has also been held with and approval has been received from the Provincial of the Congregation of the Holy Sacrament and the Mission Procurement.

As the board of the foundation, we are of course grateful to all donors who have contributed in word and deed over many years. Through this collaboration we have been able to generously offer support and future to many needy Mozambicans.

Of course, any current and future donations will still be processed until mid-2024.
